## 1. Profile of the Stichting Pavo Foundation

Today Pavo Foundation supports the foundation Ti Colibri Haiti. Our donations are used for supporting the project: l'ecole du village a Torbeck, Haïti.

Guided by the belief that every child has the right to education with equal value to succeed in life. L'ecole du village a Torbeck welcomes kids to gain free education to those who might not otherwise have it.

The Pavo Foundation was established and registered by notary in 2015. The company Pavo Sales B.V. founded the Pavo Foundation as they wanted to support local projects in underdeveloped, poor and disaster areas.

All donations made to the Pavo Foundation will directly reach their goal. Donations are made to small and decisive organisations which are active in the mentioned areas.

## 2. De goal and the actual policy

### **De goal**

The current goal of the Pavo Foundation is supporting a school in Haïti. The project "ecole du village a Torbeck" Haiti has established a school to provide education for underprivileged children.

## 5. Fund management

De funds of the Pavo Foundation are modest and administered by the Pavo Foundation (registered in Oss 63119757).

De foundation administers bank account NL11 TRIO 0390 9210 92  
(Triodos Bank, beneficiary: Stichting Pavo Foundation)

The annual funds that are raised are spent as directly as possible. The overhead costs are minimal (indication approx. 150 Euro annually) and are purely related to bank charges. The board is all voluntarily without any entitlement to any compensation.

## 6. Spending of funds

The spending of funds is decided by the board of the Pavo Foundation.
